1. Executive Session:

Subsequent to a roll call vote in Regular Session on a motion brought by Ellen Grieco, seconded by Barb Fletcher, the School Committee voted unanimously (4-0) to enter Executive Session at 9:49 p.m. for the purposes of discussing strategy with respect to litigation from the Attorney General's decision regarding Open Meeting Law complaints filed by George Harris on June 27, 2013 and Donna Bouchard on July 1, 2013 regarding the June 3, 2013 Executive Session, pursuant to M.G.L. Chapter 30A §21(a){3) and to discuss strategy with respect to pending litigation between John S. Ames IV and the Wayland Public School System, pursuant to M.G.L. Chapter 30A §21(a)(3), as such discussion in open meeting may have a detrimental effect on the litigation position of the School Committee and an Executive Session is necessary to protect the litigation position of the School Committee. The School Committee will also discuss the investigation of charges of criminal misconduct, pursuant to M.G.L. Chapter 30A §21(a)(5), to discuss a request for information from the Attorney General regarding the Open Meeting Law Complaint filed by George Harris on July 7, 2014 related to the June 3, 2013 Executive Session Minutes, pursuant to M.G.L. Chapter 30A §21(a)(1), to discuss a Public Records Request submitted by George Harris on August 4, 2014 related to the January 21, 2014 #2 and January 27, 2014 Executive Session minutes, pursuant to M.G.L. 3. <u>Discuss Strategy with respect to Litigation from the Attorney General's Decision regarding Open Meeting Law Complaints Filed by George Harris on June 27,2013 and Donna Bouchard on July, 2013 regarding the June 3, 2013 Executive Session, pursuant to M.G.L. 30A §21(a)(3):</u>

The School Committee reviewed the draft settlement agreement. In terms of payment of the fine, the School Committee will have a discussion regarding a final vote at a future meeting.

Upon a motion duly made by Barb Fletcher, seconded by Jeanne Downs, the School Committee voted unanimously (4-0) to authorize Mark Lanza to negotiate the agreement with the Attorney General's office with the changes made tonight. A roll call vote was taken as follows:

Ellen commented that Tom Greenaway of the FinCom is supportive of the School Committee's position and agrees that the individual Board members should not pay the fine from their own funds. Once the School Committee has settled, he will consult the FinCom to ask for a transfer from the cash reserve to pay the fine. Once a settlement agreement is reached, the School Committee has 30 days to pay the fine.

4. <u>Discuss Strategy with Respect to Open Meeting Law Complaint Filed by George Harris on July 7, 2014 regarding the June 3, 2013 Executive Session Minutes, pursuant to M.G.L. 30A §21(a)(1)</u>
Barb reviewed the requests for information from the Attorney General and distributed copies of the packet that she will send to the Attorney General, all of which will be kept confidential. Barb also drafted a response, and the School Committee reviewed it for language and content. Ellen will sign the response, and it will be included in the packet of information.

Ellen suggested that the Attorney General's office be contacted regarding the matrix and an explanation should be given as to why the School Committee is not releasing it. A discussion followed about the contents of the matrix. The School Committee will vote in open session to send the documents to the Attorney General.

5. Discuss Public Records Request Submitted by George Harris on August 4, 2014, related to January 21, 2014 #2 and January 27, 2014 Executive Session Minutes, pursuant to M.G.L. Chapter 30A §22:

Barb commented that she sent all the minutes to George Harris that he requested, and he came back with a request for all of the corresponding documents related to those minutes. Certain documents were not included in the packet for consideration because it was determined that they should not be released, such as the detailed peer analysis,

proposals given to various unions, the longevity analysis, the negotiations matrix, and documents regarding the METCO matter. In addition, Executive Session minutes listed as Corresponding Documents were not included in the packet because they were not requested by George Harris.

The School Committee will vote in Open Session to release certain documents related to the minutes.

Ellen proceeded to call Donna at 10:40 p.m., but was unsuccessful in reaching her. Ellen did leave a message.

7. Comply with the Provisions of a General Law of the Commonwealth, pursuant to M.G.L. Chapter 30A §21(a)(7) and Public Records Law, M.G.L. Chapter 4, §7 Clause 26(c):

The School Committee discussed an email communication from **Calculation** regarding her concerns about her child's experience of sexual harassment related to school policies and the implementation of those policies. Ellen stated her concern of both parties in terms of the privacy issue and the minutes being discoverable. Paul commented that he sees this issue partly as a matter of policy concerns, partly a matter of planning a child's return to school, and partly responding to past grievances.

Although it was recommended that Malcolm work with Paul on this matter, Paul will ask Gini Tate's advice regarding approaching this issue and if Malcolm should be involved due to privacy reasons. Ellen will inform Donna of this conversation.

Ellen volunteered to call George Harris to have a conversation about the number of complaints to date, or she could invite him to meet with the School Committee.

Paul recommended an attorney at Murphy, Hesse, Toomey & Lehane as a good resource.
