1. Executive Session:

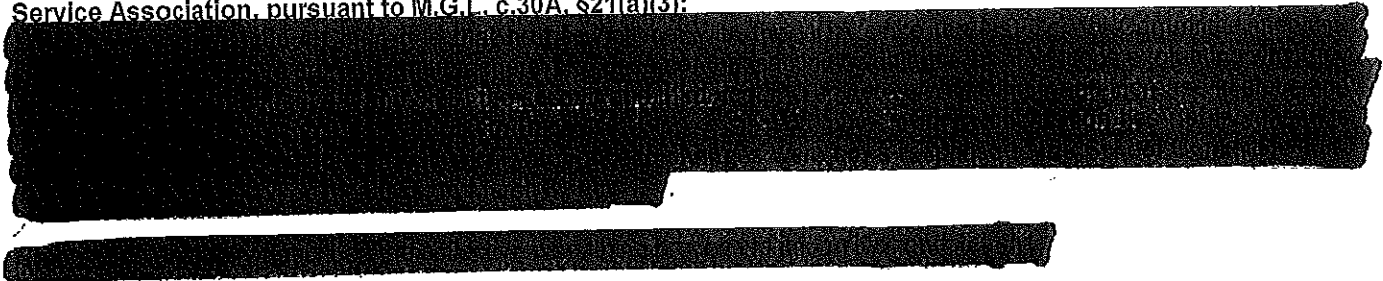
