1. **Executive Session:**

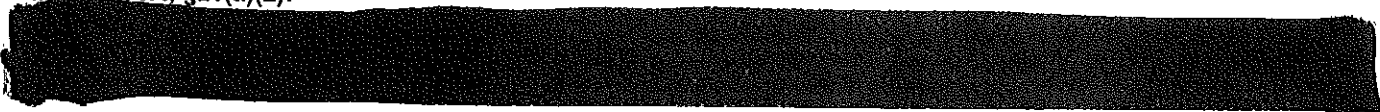
Subsequent to a roll call vote in Regular Session on a motion made by Ellen Grieco, seconded by Kim Reichelt, the School Committee voted unanimously (5-0) to enter Executive Session at 8:23 p.m., to discuss strategy with respect to and in preparation for negotiations with non-union personnel, the Superintendent, as permitted by M.G.L. c.30A, §21(a)(2), as such discussion in open meeting may have a detrimental effect on the bargaining position of the School Committee and an Executive Session is necessary to protect the bargaining position of the School Committee; and review for possible declassification Executive Session minutes as listed on the meeting notice, as permitted by M.G.L. c.30A, §22.
